The University of Illinois will begin proceedings to update the current Campus Master Plan, which was approved by the University of Illinois Board of Trustees in 2007, to guide future anticipated physical development of the Urbana-Champaign campus.

The Master Plan will guide our development of the physical environment to improve campus quality of life, simplify and enhance campus organization, establish a positive unified campus identity, improve operational efficiency and create facilities that support our learning, discovery and outreach missions..

Scope of Plan

Professional Services Consultant will:

- Meet with constituents and interested parties for input and ideas
- Develop and maintain a public website to disseminate information and solicit feedback
- Analyze existing and future conditions
- Coordinate and assimilate other existing campus outlooks, such as Campus Strategic Plan, Utility master plan, Parking master plan, Illinois Climate Action Plan, and college and department facilities plans
- Strategically integrate academic plans and programs with ongoing development of physical campus space
- Develop a master plan that provides an updated guide to anticipated physical development
- Create an Executive Summary and full technical report including Design Guidelines



Process

- Initial Approval from Provost & Chancellor
- Development of Draft Scope, Schedule and Structure
- Approval of the Chancellor's Capital Review Committee (CCRC) to proceed with Campus Master Plan Update
- Selection of Professional Services Consultant (PSC) to prepare updated plan
- BOT Approval of PSC
- **Information Gathering**
- Soliciting input from Campus and Community Stakeholders
- Presentations of Draft Master Plan Report
- Review & Approval of the Master Plan by CCRC
- Review & Approval of the Master Plan by the President & Chancellor
- Review & Approval of the Master Plan by the Board of Trustees
- Master Plan Becomes Effective for Long-term Outlook

- Solicitation of Input from Stakeholders – April 2016 – May 2016
- Master Plan Draft Presentations – January 2017
- Master Plan Final Presentations & Board of Trustees Approval – May 2017
